## MANAGERS MESSAGE

### **Welcome Summer**

As we welcome the long, warm days of summer, there's a renewed energy across our communities. Whether you're spending time at the lake, working in the fields, or enjoying a backyard barbecue with family and friends, summer is a special time for us in Northern Minnesota. At Clearwater-Polk Electric Cooperative, summer also marks one of the busiest times of year for construction, maintenance, and system planning. And this year, it brings some important developments we want to share with you.

### Electric Safety in the Summer Months

With more outdoor activity comes a greater risk of electrical accidents, many of which are preventable with a few basic precautions. Please be mindful of overhead power lines when setting up ladders, trimming trees, or using tall equipment. Teach children to never climb trees near power lines. And if you plan on digging — whether to plant a tree, install a fence, or put in a new mailbox — remember to call 811 before you dig to locate underground utilities. These small steps can prevent major accidents.

Also, if you're using extension cords for outdoor events, make sure they are rated for outdoor use and are not frayed or damaged. Keep electrical appliances and cords away from pools, sprinklers, and wet grass. Electricity and water do not mix — and even a small oversight can have serious consequences.

Your safety is always a top priority at Clearwater-Polk, and we encourage all members to take extra care while enjoying the outdoors.

### Cost of Service Study Completed: Board Reviewing Rate Options

We also want to share an update on our recent financial planning efforts. Earlier this year, Clearwater-Polk Electric Cooperative engaged the services of our financial partner, the National Rural **Utilities Cooperative Finance Corporation** (CFC), to conduct a comprehensive cost of service study (COSS). This study examines how the cooperative's costs — including energy purchases, infrastructure investments, operations, and maintenance — are allocated among different rate classes. The purpose of the study is to ensure that rates remain fair, equitable, and aligned with the actual cost of providing electric service to each member class.

The final results of the study were presented to the Board of Directors at their April 30th meeting. After careful analysis, it is clear that a rate adjustment is necessary to reflect the true cost of providing reliable electric service in today's economic environment. Costs have continued to rise across the utility industry — from the cost of power we purchase from our wholesale provider, to the materials and equipment we need to maintain our system, to labor and regulatory compliance.

The Board is now in the process of evaluating the study's findings and weighing the available rate design options. While no final decision has been made, it is anticipated that a rate increase will go into effect on **August 1, 2025**. Details about the changes, including any adjustments to the access charge, demand charge, and energy usage rates, will be shared with members once the board has approved the changes. Information will be posted on the Cooperative's website, the bill print message and upcoming newsletters. We recognize that no one wants to see their electric bill go up. That's why this process has been approached with diligence and care. Our goal is to implement a rate structure that recovers necessary revenue while maintaining fairness and transparency — and without overburdening any one group of members.

### **Construction Season in Full Swing**

Summer also means construction season is in full swing. Our line crews are working hard on new service installations, system upgrades, pole replacements, and the many maintenance projects that keep our system safe, reliable, and strong. This work is critical to meeting our long-term reliability goals and ensuring the electric system is ready to handle both today's demands and tomorrow's growth.

If you see crews working near your home or along the roadside, we kindly ask you to give them plenty of space to do their job safely. Slowing down in work zones, avoiding distractions while driving, and keeping a safe distance from work areas all help us avoid accidents and protect the men who keep your power flowing.

### Right-of-Way Maintenance: Keeping the Lines Clear

Along with construction work, we continue to prioritize our right-of-way maintenance program. Trimming and clearing vegetation along power lines is one of the most important things we do to prevent outages — especially during summer storms, which can bring high winds and heavy rain. Trees or branches in contact with lines are not only a leading cause of outages but can also pose significant fire and safety hazards.

Our crews and contractors follow best practices for vegetation management, and all work is done with an emphasis on environmental responsibility, longterm system reliability, and member communication. If a crew is working in your area, you may receive a notification
