other members. The group is kept up to date on current legislative actions that could affect the cooperative and the membership.

Clearwater-Polk Electric Trust Funding and Donations

The Clearwater-Polk Electric Trust Fund committee is scheduled to meet in June for the grant-funding meeting. Request for funds will be accepted until Thursday, May 11, 2023. Application blanks can be found on our website www.clearwater-polk.com, or from one of the committee members, Cindy Benson, Lois Rydeen or Laurie Pemberton. You may also contact our office to have a form mailed to you.

Donations from the Trust will generally (Brennan Olson) be made to organizations which benefit the service area community of Clearwater-Polk Electric Cooperative. Non-profit Organizations which have been granted IRS Code 501^o (3) status and serve a large number of people will be given priority.

Donations from the Trust will generally not be made for:

- A. Lobbying, political and religious organizations
- B. Fraternal, and labor organizations
- C. Fund-raising dinners, raffles and other events
- D. Individuals
- E. National fund drives
- F. Advertising
- G. Economic development projects.

The following factors will be considered in the evaluation of all funding requests.

A. Potential benefit to area residents and the entire community;

B. Level of community support for the program or project or organization requesting the funds;

C. Fiscal and administrative capability of the organization to deliver a quality service or program; and

D. Results that are predictable can be evaluated.

All donations to organizations will be published in the Current Activities Newsletter.

5 STEPS FOR SAFE DIGGING

Working on an outdoor project? Careless digging poses a threat to people, pipelines and underground facilities. Always call 8-1-1 first. Here are five easy steps for safe digging:



1. NOTIFY

Call 8-1-1 or make a request online two to three days before your work begins. The operator will notify the utilities affected by your project.

2. WAIT

Wait two to three days for affected utilities to respond to your request. They will send a locator to mark any underground utility lines.



3. CONFIRM

Confirm that all affected utilities have responded to your request by comparing the marks to the list of utilities the 8-1-1 call center notified.



Respect the markers provided by the affected utilities. The markers are your guide for the duration of your project.

5. DIG CAREFULLY

If you can't avoid digging near the markers (within 18-24 inches on all sides, depending on state laws), consider moving your project location.

ANNUAL REPORT TO MEMBERS



General Manager

You have heard for years your electric service that Clearwater-Polk Electric provides you, summed up by three key priorities: Safety, Reliability, and Affordability.

SAFETY

When coming into contact with electricity, there are no second chances. Through safety trainings, simulations and having a proactive safety committee, Clearwater-Polk's efforts on safety are ever evolving. The goal is zero accidents so when work ends, all employees return home to their families. We will continue to grow, adapt and develop our safety efforts.

RELIABILITY

These past couple of years Clearwater-Polk's service territory has been very fortunate to not have endured any major storms. However, weather was the leading factor for the outages this past year. Although our number of outages were higher than 2021, Clearwater-Polk ended the year with a reliability rate of 99.93%. Right-of-Way maintenance continues to be one of the largest expenses.

In addition to right-of-way maintenance, Clearwater-Polk contracts with EXO, Inc. to conduct pole inspections each fall. The service territory is broken down into approximately 10 different sections with one of the sections being inspected each year putting the system on a 10-year rotation. Clearwater-Polk's failure rate has been historically low, at approximately 1.5%. In 2022 the section inspected was the first in the 10-year rotation to be repeated. I need to thank my predecessors for putting this plan together because this year there were 1,948 poles inspected and only 6 rejected and marked for replacement. This dropped the failure rate from 1.5% to three-tenths of a percent.

Another significant part of reliability is planning for system improvements. Every four years your cooperative puts together a 4-year construction work plan. This includes replacing overhead and underground conductors, replacing transformers, pole replacements, building new services, etc. Through the development of this plan, these projects are carefully analyzed to make sure that we are making the best use of the dollars spent. This past year your board of directors approved the 4-year work plan for just under \$6 million, averaging over \$1.4 million per year. Maintaining and improving system reliability will continue to be a key priority of your electric cooperative.

AFFORDABILITY

Clearwater-Polk is not alone when it comes to feeling the pressure of what is happening in our world today. Price inflations, supply chain issues and government regulations have us all concerned about affordability. Your electric cooperative has absorbed significant increases in costs of doing business. In 2020 Clearwater-Polk went through a cost of service study which indicated that the cooperative's minimum fixed charge (facility charge) could be \$50, which is \$13 more than the current rate of \$37. The facility charge pays for a majority of Clearwater-Polk's local costs that include everything required to provide electric power to you other than the purchased power costs and demand costs. These include 1,500 miles of power lines, 25,000 poles, a fleet of 10 vehicles, plus all the associated hardware required to operate the Cooperative's distribution system. The challenge of affordability is real for everyone. Clearwater-Polk is not anticipating a rate adjustment for 2023, but we are keeping a close watch on the costs of doing business, analyzing what is happening today, while planning for tomorrow.

SEVEN COOPERATIVE PRINCIPLES

This annual meeting, we highlighted the seven cooperative principles. As I have said before, they define who we are and are the key reason that America's electric cooperatives operate differently from other electric utilities, putting the needs of the members first. In the spirit of the seven cooperative principles, and specific to number 7, Concern for Community, this annual meeting's guest speaker's key topic focuses on economic development and how Clearwater-Polk can play a role to help promote growth in the communities we serve. Clearwater-Polk's concern for community is highlighted in many different activities that we participate in throughout the year. This year's message is to remind co-op members that Clearwater-Polk Electric is more than just a power provider, we are part of the communities we serve, and we are a resource to help our communities grow and prosper.

FINAL THOUGHTS

In spite of the challenges that we have faced this past year, Clearwater-Polk remains financially sound. Currently, Clearwater-Polk Electric has 1,522 miles of line that serves approximately 4,600 electric services. It is governed by 7 cooperative members serving as directors and employs 14 full-time employees. A total utility plant of over \$30 million, total equities over \$12 million, and year-end operating margins of over \$220,000. The directors and employees will continue to work hard to provide the cooperative's members the safe, reliable and affordable electricity that you deserve. Clearwater-Polk will continue to move forward building on the strong foundation that began over 76 years ago.

Thank you to all the board members, especially retiring board member Bob Johnson, and all the employees, including this year's newly retired employee, Ben Eastley for all the hard work and dedication you show to the cooperative, to the support you give me and for the exceptional service you provide to all the members of Clearwater-Polk Electric.

I would also like to thank the members who submitted their petitions for nomination to the board of directors. Congratulations to Dennis Engebretson (District 1) and Harlan Highberg (District 2) for their re-election to the board of directors, and congratulations and welcome to Cheryl Grover as the new director in District 2.
